 - **Planning and Preparation:** Successful completion of Fall 2020; Spring 2021 planning for same protocol as Fall 2020; PC Faculty, Staff, and Student surveys in progress; PC Tenure and Promotion timeline extended in alignment with UofSC Columbia due to COVID-19 impact.

FALL SEMESTER ACCOMPLISHMENTS – CONGRATULATIONS!

- **USC Lancaster, Salkehatchie, and Sumter - TRIO Program Grants Awarded**
 - The U.S. Department of Education has awarded more than \$1 Million to the TRIO Programs across USC Lancaster, USC Salkehatchie and USC Sumter in support of their work with income-challenged and first-generation students. In honor of the accomplishment, Pres. Caslen awarded the UofSC President's Coin of Excellence to Matt Williamson (USC Lancaster), Latoya Robinson (USC Salkehatchie) and Lisa Rosdail (USC Sumter).
- **USC Union – Timken Foundation Grant Purchases Virtual Reality Lab Microscopes**
 - Twenty-four new Zeiss microscopes were recently purchased for the Virtual Reality Lab in the Science & Nursing Building with grant funding from a local Timken Foundation grant in the amount of \$100,000. The laboratory resources will support the new Bachelor's of Science in Nursing Program offered in partnership with USC Aiken.
- **Palmetto College Columbia – Students and Faculty Inducted into Alpha Sigma Lambda Adult Honor Society**
 - The Alpha Sigma Lambda Virtual Induction Ceremony was held on October 22nd, inducting ten students and five honorary inductees from the faculty and professional staff from across Palmetto College. Thanks to Dean Ron Cox and Ms. Jean Carrano for planning and executing an outstanding virtual event on behalf of Palmetto College.
- **Palmetto College Central Support – 2020 Rural Utilities Service Distance Learning and Telemedicine Grant Awarded**
 - Palmetto College was awarded the \$431,278 grant that will be used to purchase new technology to update the two-way video classrooms at Palmetto College Columbia, USC Salkehatchie, USC Lancaster and USC Union. This is the second such grant received for a total of nearly \$1 Million, allowing all PC distance learning classrooms to be updated. Regular meetings have been ongoing with the SC CHE, CAAL, CAD, ACAP, F&F, APL, AAC, the Chancellor's Cabinet, and the Academic Deans. Jean Carrano keeps the agendas and meeting notes on file for each of these groups and you are welcome to see any of the above. Again, thanks to the faculty of all of PC for working through recent difficulties in such a professional and selfless way so that our students can continue to receive an excellent university education. Please continue to help our students and continue your willingness to accommodate our students' needs. These special accommodations can make the difference between a student dropping out and graduating.

The T&P yearly update is as follows: 2 applications for tenure and promotion to Associate Professor and two applications for promotion to Professor. The files are currently with the local T&P committees. The candidates will receive notice of the committee's recommendation by December 1st. The files will then be reviewed by the deans before moving on to the Palmetto College T&P Committee in January.

The T&P workshop will be held on Friday, January 22. Dr. Obi Johnson has indicated it will be held virtually and more information will be forthcoming.

Chris Rinehart is in her second year working on PC Assessment. She and Bob Dyer are testing the new PC Carolina Core Assessment Program, working with artifacts from GSS, GHS, and ARP. We will assess AIU, GFL, and VSR in the Spring 2021. If your course is randomly selected, we greatly appreciate your help with assessment. Chris Rinehart is the person to contact with any questions or concerns.

Please thank Bob Dyer when you see him. For the second straight year Bob has successfully written and been awarded technology grants that will bring IT improvements to every Palmetto College classroom. This year's grant of approximately \$450K will finish the improvements begun last year. As you teach using the latest equipment think of Bob.

**REPORT TO THE PALMETTO COLLEGE CAMPUSES FACULTY SENATE
20 November 2020 C.E.**

Greetings, Palmetto College Senators. Thank you for the opportunity to report to this body, both in my capacity as Campus Dean for Palmetto College Columbia, as well as Associate Dean for Diversity, Equity, & Inclusion for Palmetto College.

- I. Palmetto Pathway
 - Palmetto Pathway cohort remains at 49. Students are currently being advised (virtually) for their SPRING 2021 schedules.
 - Thank you to faculty from all of the Palmetto College campuses who have taught (or who will be teaching) in this important bridge program.
- II. BLS/BOL
 - Fall 2020 – enrollment in BLS & BOL stood at 297 (146 & 151, respectively). 46 students have applied for December 2020 graduation.
 - SPRING 2021 – current enrollment stands at 120 (57 BLS & 63 BOL)
 - The Academic Advisory Council (AAC) has met several times and will be submitting a report to the Senate at this afternoon’s session.
- III. Lexington Transfer Center
 - We are still in discussions with Lexington School District 1, which has expressed interest in working with Palmetto College to offer upper-level foreign language (FREN & SPAN) courses for dual credit in the district’s language immersion program. Issues to be resolved include logistics regarding placement testing and faculty course approval.
- IV. Fort Jackson
 - The revised MOU with Fort Jackson is still in the approval process.
 - The Chancellor has approved the change to Fort Jackson program’s description in the UofSC *Undergraduate Bulletin*, which this Senate approved at its last gathering. The change will be submitted to the Provost’s office for inclusion in the 2021 *Bulletin*.
 - Student enrollment in the 21 courses being offered at Fort Jackson in FALL 2020 was 285 (mostly UofSC Columbia students).
 - 19 courses are scheduled at Fort Jackson for SPRING 2021. Current enrollment stands at 276 students.
 - The Veterans’ Service Center ribbon-cutting ceremony was held on 11 November on the UofSC Horseshoe. The Center is located on the first floor of the James F. Byrnes building.

V. Diversity, Equity, and Inclusion

- The Council of Academic Diversity Officers continues to meet regularly. CADO is currently attempting to arrange a meeting with representatives from the Office of Undergraduate Admissions, noting that our capacity to support the University's diversity efforts are intertwined with (and impacted by) what goes on in our admissions offices.
- Each Palmetto College Campus has now established its local DEI committee. We are still waiting for one campus to identify its representative to the central PC DEI Council.
- Palmetto College has submitted several initiative funding requests to the USC administration, based on priorities noted in the President's strategic plan.

VI. REACH Act

- 2019 – REACH Act introduced into the General Assembly (to replace law originally passed in 1924, which required instruction in the documents, an examination on the documents, and a loyalty oath). Law would apply to all students in SC public colleges completing a baccalaureate degree. (Requirement is explained below.)
- As currently written, the law's requirements do not apply to associate's degrees (and thus not to the technical colleges) so there is concern about how to ensure compliance with the law for students who enter UofSC with transfer credit from other institutions. (This potentially will be of concern to us for students entering Palmetto College bachelor's degree programs from the technical colleges.)
- At its meeting on October 7, the UofSC Faculty Senate approved the following proposal to meet requirements of the REACH Act:

Insert the following blurb right after Carolina Core Courses and before Special Academic Opportunities in the Undergraduate Bulletin.

Other Requirements

All undergraduate students must take a 3-credit course or its equivalent with a passing grade in the subject areas of History, Political Science, or African American Studies that covers the founding documents including the United State Constitution, the Declaration of Independence, the Emancipation Proclamation and one or more documents that are foundational to the African American Freedom struggle, and a minimum of five essays from the Federalist papers. This course may count as a requirement in any part of the program of study including the Carolina Core, the major, minor or cognate, or as a general elective.

- According to Dr. Sandra Kelly, a grants program will be implemented for faculty to apply to revise courses. More information on this will be shared as it is made available.

VII. Center for Integrative & Experiential Learning (CIEL)

- Committee met virtually on November 16. Major items noted:
 - Challenges due to COVID (e.g., travel study, internships, etc.)
 - QEP Update – new name for QEP: “Experience By Design” – branding will become more official as the March 2021 SACS visit approaches.
 - One of the priorities is going to be to focus on PELL-eligible, first generation, and other underrepresented student groups.
 - Much discussion of preparation for the SACS visit, including plans for assessment of the QEP outcomes.

VIII. Faculty & Staff News

- On September 3, 2020, Dr. Julia Elliott's short story "Hellion" was featured on the NPR *Selected Shorts* Podcast "Coming of Age," a segment hosted by author Tayari Jones. The podcast is a recording of actress Donna Lynne Champlin's reading of Julia's story at "Selected Shorts: Best American Short Stories 2019 with Anthony Doerr," at Symphony Space, a theater in New York City. The podcast may be found on Symphony Space's website: <https://www.symphonyspace.org/selected-shorts/episodes/coming-of-age>.
- For the last two years, Dr. Elliott's service learning SC Honors College class has worked with Nickelodeon Theatre to promote a feminist horror series. This year, the students have produced all content for a SCHC-hosted virtual series that can be streamed with your USC ID and password. The course is listed in the SCHC "Cool Courses" section. This year's theme is "Haunted Moms: Motherhood, Monstrosity, and Horror." - Dr. Shelley Jones' article titled "The Power of Gossip from Mary Robinson's *Tabitha Bramble* to *Lyrical Tales*" has been accepted for publication in *Essays in Romanticism* (Liverpool University Press), forthcoming Fall 2021.
- On October 22, Ms. Melissa Lowe, student services manager for BLS & BOL, was inducted into the Alpha Sigma Lambda National Honor Society, in recognition of her many years of dedicated work on behalf of all, but especially non-traditional, students.
- Palmetto College has hired two professional academic advisors – Jacob Bratcher and Chelsea Corbett – who began their duties (virtually) on October 01. They will work primarily with students in the BLS and BOL programs on all PC campuses.
- At its Faculty Organization meeting on 04 November, the PC Columbia Faculty unanimously agreed to adopt an annual evaluation procedure based on the calendar, not academic year.
- Dr. John Abdalla, Instructor of History, has announced that this Fall 2020 semester will be his swan song and that he will not be returning to Palmetto College after the winter break. We offer our sincere thanks and deep appreciation to him for his many years of service to the students of Palmetto College (in its many different incarnations and manifestations), as well as for his collegiality, his warmth, and his gentle good humor.

My appreciation to the Senate for permitting me this time to report on some of the happenings at UofSC Palmetto College Columbia.

As of the freeze date of October 22, 2020, 1810 students (headcount) are registered for Fall 2020. This represents increases of 10.37% in headcount and 4.41% in FTE.

Athletics

From the AD: All athletic teams at USCL completed their fall practice seasons successfully despite the challenges presented by COVID-19. The NJCAA has mandated that in order to hopefully have a successful competition year, all of our sports will compete in the spring. The NJCAA has also approved a blanket waiver for athletic eligibility for all athletes competing in all sports for the 2020-2021 school year. We are looking forward to having a safe and successful spring for all teams.

Our new **Director of Student Success and Retention** has been named. We are excited to welcome Ms. Asheley Schryer to USC Lancaster. She is currently the Associate Director of Student Services in the Office of Undergraduate Research at USC Columbia. Ms. Schryer will begin her duties here on Monday, December 7, 2020.

Faculty Accomplishments:

Dr. Todd Lekan, Associate Dean, has organized a Recent Faculty Accomplishments webpage that is updated regularly and can be accessed at this [link](#).

Recent faculty accomplishments include:

Dr. Lisa Hammond (English): Several of her poems have been published and recognized for their excellence. Her poem “Hydrangeas” was selected from more than 400 submissions as the winner of the Saluda River Prize for Poetry from the Jasper Project and will be published in *Fall Lines* later this year. The poem and an interview with Dr. Hammond was featured on the Jasper Project blog, and also included a new poem, “Elizabeth Warren Dreams of Kissing Babies.” Her poem “many moons” was chosen by the Poet Laureate of the City of Columbia to be published in the booklet, *Poetry on the COMET: Write on Time*, and featured on buses on the Central Midlands Regional Transit Authority. In addition, her poem “To a Son Leaving Home for College” was published this summer in *Sheltered: South Carolina Artists Respond During the 2020 Pandemic*.

Professor Fran Gardner (art): Recently Prof. Gardner was invited to be a part of a media campaign by the National Association of Women Artists. She will be the featured Artist of the Day on April 7, 2021 and will be featured on NAWA’s Instagram and Facebook platforms for that day with images of her work, her bio and photos.

Her piece titled “Alpha-Beta” won first place in the juried exhibition, Small Chapters, at Coastal Discovery Museum in Hilton Head, SC. The show runs now through November 30, 2020. And Prof. Gardner has five pieces accepted for the exhibit, Textile Impact, at the Anderson Arts Center in Anderson, SC. This exhibit showcases “a range of textile works highlighting the diversity of processes, materials, and presentation within this wide medium and industry.” The show will be open from December 8, 2020- January 28, 2021.

Here are a few other of Gardner’s noteworthy achievements:

- “Some Like it Hot,” National Association of Women Artists SC Chapter, includes artists from SC, FL and MA (online only) opened in August and still accessible online.
- 131st Members Exhibition, National Association of Women Artists, includes artists from across the United States (online only but traditionally held in New York) October 2020.

- “Inspirational Journeys,” The Vendue Art Hotel in Charleston, SC and National Association of Women Artists SC Chapter, includes artists from all NAWA chapters (face-to-face through November 30th and online).

Professor Chris Judge (archaeology and anthropology): Prof. Judge has coauthored a paper entitled “Wateree Bug Ceramic Motif” which was published in *Legacy* (The South Carolina Institute of Archeology and Anthropology), 8-11. The paper examines the possible origin and cultural significance of images of the bug on ceramic vessels.

Archaeological Society of South Carolina features Prof. Judge in its [“Ask an Archaeologist” interactive video](#).

Judge served as curator of “Share a Little of that Human Touch”: [The Prehistory of South Carolina Exhibit](#).

Professor Marybeth Berry (theatre and speech) has produced two distanced/virtual theatrical productions in Fall 2020: a student production of *The Scarlet Letter* in October and an original, two-person production entitled *On the Spectrum* in November.

Dr. Todd Lekan (philosophy and Associate Dean) “The Mask as Metaphor: Deweyan Reflections in the Time of a Pandemic.” *Dewey Studies*, Vol 4. No. 1, 2020, pp. 96-101. This is a special volume of invited authors with a goal of short and timely pieces on the pandemic and police violence written from a Deweyan perspective.

Dr. Steven Campbell (political science), Ms. Danelle Faulkenberry (Palmetto College Coordinator), Mr. Brandon Newton (campus outreach and adjunct instructor of business), and Ms. Ryleigh Waiters (Director of Student Life) who were awarded an Arras Foundation Horizon Grant for their proposal “CLEVER (Campaign Literacy Educates Voters to Encourage Responsibility) which encourages voter education, registration, and responsibility.

Corporate Partnership and Engagement

Updates from Albert Blackmon:

- We now have a membership presence in the Rotary Club of Indian Land (Lunch Club).
- The USCL Indian Land Business Advisory Board is being established, and we hope to have our inaugural meeting later this month.
- While we continue to gain input for the business community regarding training and development needs, we are in talks with Microburst and should have a custom initial offering under construction by the end of the year.

The USCL related **Lancaster County Capital Project Sales Tax Program proposals** were approved in the referendum vote earlier this week. USC Lancaster had 2 projects on the list: one in the amount of \$1,000,000 for safer and better connections/surface crossings across Highway 9 between our campus and the community and the second, also

in the amount of \$1,000,000, on behalf of the Educational Foundation for facility and infrastructure enhancement to support the expansion of BSN nursing at USC Lancaster.

COVID update

USC Salkehatchie has had 14 cases since classes started; 12 students; 2 staff. No outbreaks and no evidence of spread within classrooms or on campus. We have held several on-campus testing events with both DHEC and with USC Columbia Student Health on both campuses.

Enrollment

Overall headcount was down this fall, but many of those were due to non-degree classes that we could not offer due to COVID. Full-time enrollment was up slightly over Fall 2019.

Campus News

USC Salkehatchie hosted the USC System Academic Leadership program in Walterboro on November 6.

We are involved in a Rural Broadband initiative to bring hi-speed internet access to Allendale. We will provide a WiFi antenna on top of the ETV tower on our campus, and provide a free public WiFi hotspot on campus for the community too.

New and existing grants programs: new STEM coordinator position search is active; new Leadership Institute Director position search next spring.

Assistant Dean of Student Services Jane Brewer has announced her retirement Dec. 31, after 42 years of service to the Salk campus. Dean Brewer's service to the campus has been legendary-- and her absence next year will be felt by all. We have a search for a new Assistant Dean for Student Success and Retention active. Faculty Accomplishments

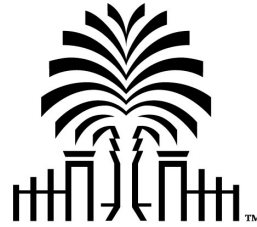

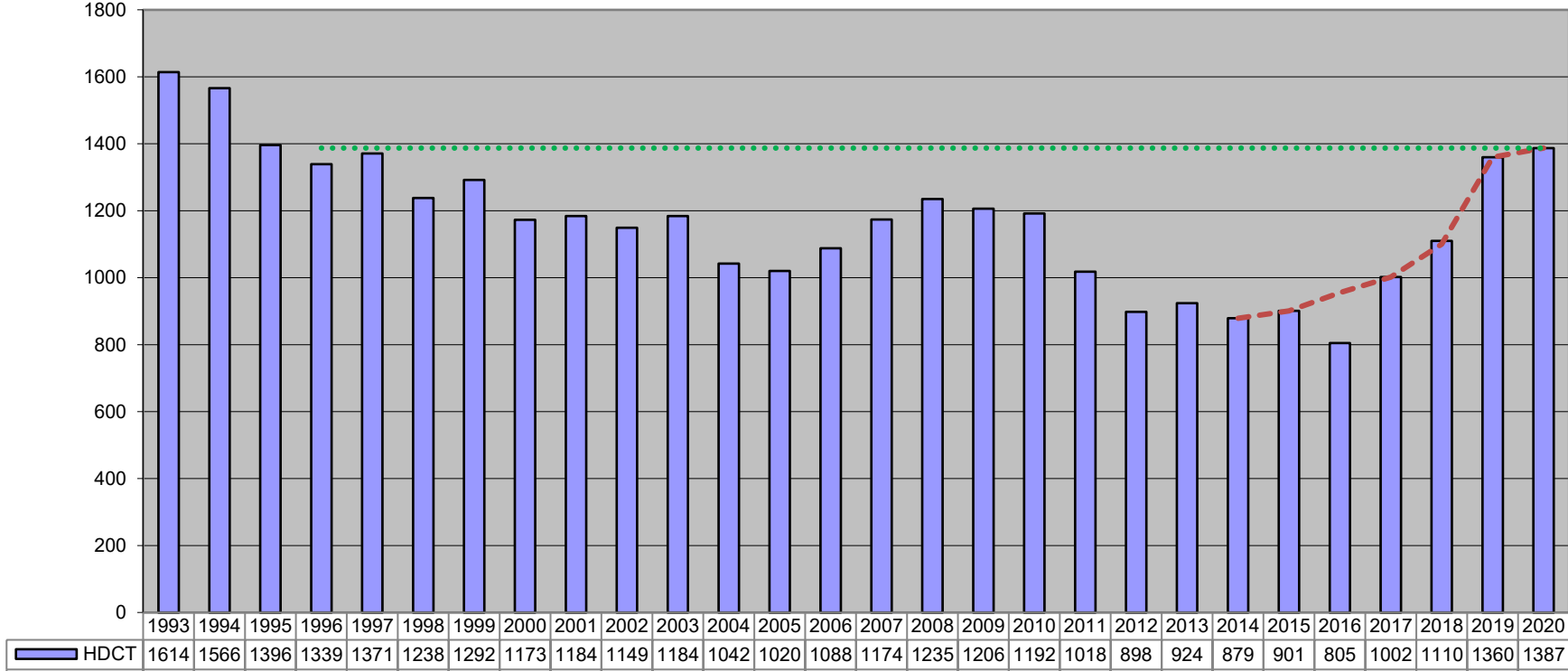

Graduation Rate = % of students earning an Associate's degree within 150% of program time

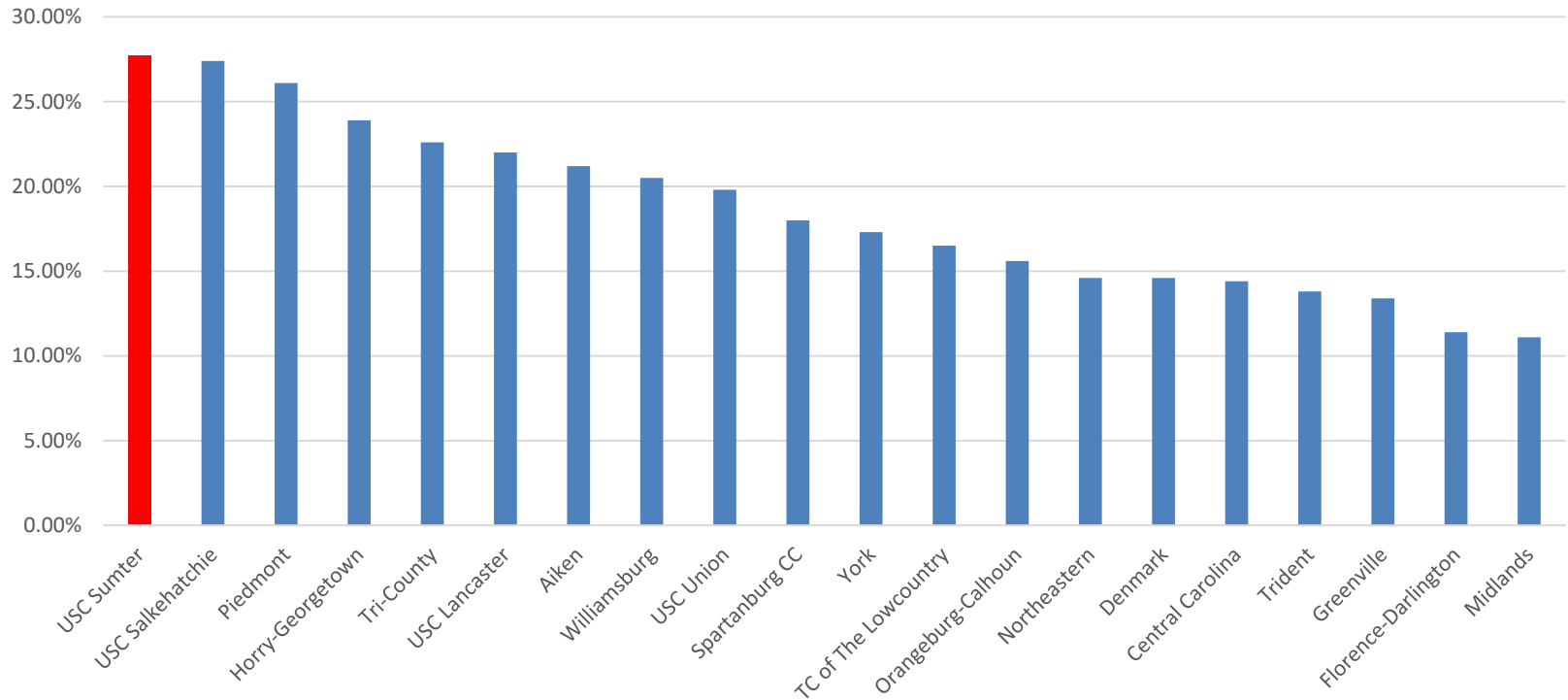


Success Rate = graduation, transfer, or continuing studies after 150% of program time

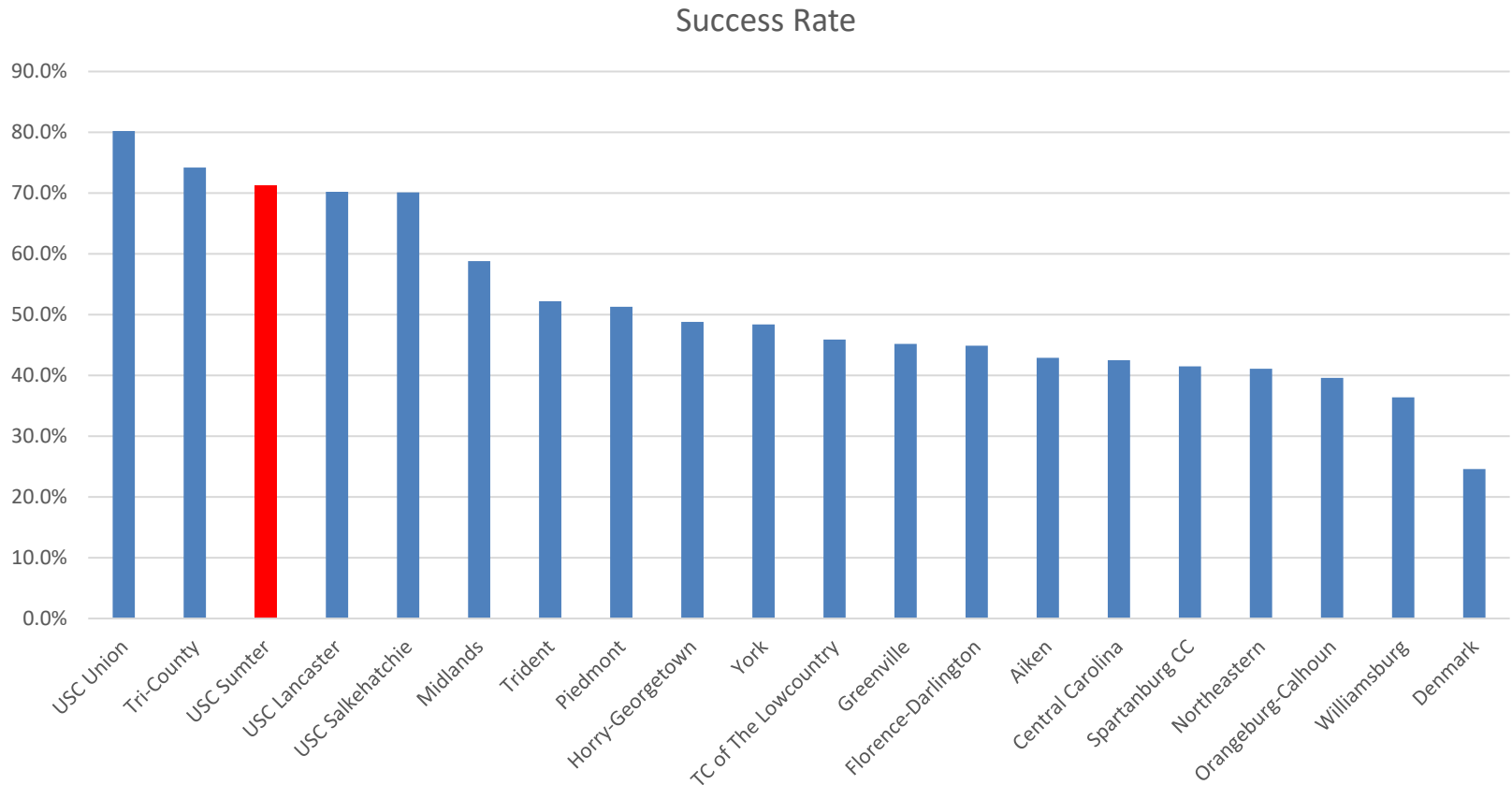

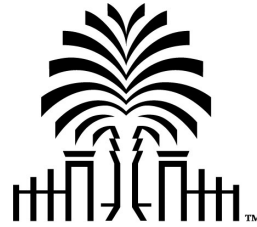

Dean's Report
November 20, 2020

Students

- Fall 2020 preliminary freeze data showed Union headcount at 1,071 and FTE at 633. This includes increases in key metrics of continuing students and new freshmen on campus in Union. And this builds on the trends of a 29% increase in first-time full-time freshmen in terms of 5-year change; and a 68% increase in terms of 10-year change.
- Our athletic teams have been able to compete in some limited scrimmages this Fall and look forward to competing in the Spring. This includes the new addition on campus of women's volleyball who will elevate to NJCAA next Fall from club level.
- Students Tomi LaChance and Caden Jackson presented on their research during USC Union Research Club's Virtual Fall Colloquium and will be included in USC Lancaster Research Club's virtual conference programming as part of a Union Takeover the week after Thanksgiving.
- Looking ahead, Spring schedule features approximately 67% of classes in person, with enrollment expected to be at least flat, if not up from last Spring.

Faculty & Staff

- Congrats to Assistant Professor of Fine Arts, Jennifer Emswiler, for her recent artwork being included in Fusion Art's online international juried art exhibition, alongside submissions from all over the world (<https://www.fusionartps.com/5th-anniversary-art-exhibition-november-1-2020-october-31-2021/>). She also shared her creative process for that work during our Research Club's Virtual Fall Colloquium, which will be featured during the Union Takeover week (see above).
- Congrats to Full-Time Instructor of Spanish/French/Italian, Kevin Torres, as he has been accepted into an MBA program to advance his knowledge and expand on his repertoire of course offerings for the campus. Kevin also presented on his research on the Holocaust during our Research Club's Virtual Fall Colloquium, which will also be featured during the Union Takeover week (see above).
- New student organization launched on campus, the Bantam Health & Fitness Club, by faculty co-supervisors, Jennifer Emswiler and Dr. Emily Schafer (Assistant Professor of Psychology).
- Milestone celebrated by Financial Aid Director, Bobby Holcombe, who crossed the threshold for 30 years of service on the Union campus.
- The Union County Carnegie Library, which we partner with to house/staff our USC Union Library as well, has been named the winner of the InnoVision Award in Community Service category due to their efforts to expand broadband access in Union County.

Facilities

- New Student Services Building on Main Street next to Bookstore is up and running, with Admissions and Financial Aid.
- New Lactation Room on campus ready for use, on third floor of Main Building, for students/faculty/staff.

- The old library renovation project is on schedule to be completed by early January, with four new classrooms and four new faculty offices. The classrooms will feature two active learning classrooms designed specifically for world language instruction.
- New carpeting and paint in the Academic Affairs suite in the Main Building to be completed over the holiday break.
- Project to create new Sim Labs for the Aiken BSN program on the Union campus in preliminary stages with anticipated completion in summer 2021, in old post office building.
- Preliminary planning begun for conversion of Founders House on campus into a Fine Arts space, connecting to campus garden.
- ADA restroom and security hardware projects also in preliminary stages, aiming to launch immediately following conclusion of Spring semester.

Budget

- As of October 31, we were 33% of the way through the budget year. Our expenses at that point were at 32.6%, so well on target. This includes expenditures for COVID related items that we have been reimbursed for or will be reimbursed for at a later time.
- Fall PC revenue is estimated to be \$342,831, which will put us ahead of our tuition projections for Fall. Additionally, we have received 54% of our projected tuition revenue for Summer – which would have us needing \$123,549 for Summer 21 (May/June courses) – last year’s May/June summer revenue was \$189,146, so we are also ahead on overall summer revenue.

Also excited to have Success Rate of 80.2% for first-time full-time freshmen entering in Fall 2015, which is the best rate in the state of South Carolina among all 2-year institutions.

Report to the PC Senate

November 20, 2020

This semester the committee has discussed the following issues

- I. BLS major changes
 - a. Adding African American Studies (AFAM) to major options list for BLS
 - b. Accepting lower-level CAS major courses
 - II. Reviewing the foreign language requirement
 - III. New programs, such as Cultural Studies
 - IV. The currently on-hold Legal Studies BLS major option
 - V. The hiring of professional advisors for BLS/BOL
 - VI. Possible changes to PALM 401
-
- I. The committee decided to hold course on changes to the BLS major while continuing to allow exceptions for individual students as warranted
 - II. The committee also decided to hold the course on the foreign language requirement
 - III. We are hoping that the provost gives the green light for new program development within Palmetto College so that programs like cultural studies can proceed through the approval process
 - IV. Legal Studies continues to be on hold
 - V. The hiring of two new professional advisors for BLS and BOL led to a long discussion at our second meeting and to a special meeting on November 19. Discussions primarily revolved around the roles of campus advisors in the new advising schema, and those discussions are ongoing
 - VI. Discussions about revising PALM 401 to reduce perceptions of the course being disproportionately difficult are also ongoing. Initial talks started with the faculty teaching the course out of PC Columbia but will expand to include other faculty who teach the course
