

Drug-Free Schools and Campuses Regulations [Edgar Part 86] Biennial Review Policies and Procedures

The administrations of Palmetto College (PC) and the Palmetto College campuses (Lancaster, Salkehatchie, Sumter, and Union) certify that they have adopted and implemented an alcohol and other drug (AOD) prevention program for their students and employees that, at a minimum, includes –

- 1. The annual distribution to each employee, and to each student who is taking one or more classes of any kind of academic credit except for continuing education units, regardless of the length of the student's program of study, of:
 - Standards of conduct that clearly prohibit, at a minimum, the unlawful possession, use or distribution of illicit drugs and alcohol by students and employees on its property or as part of any of its activities.
 - A description of the applicable legal sanctions under local, State, or Federal law for the unlawful possession or distribution of illicit drugs and alcohol.
 - A description of the health risks associated with the use of illicit drugs and the abuse of alcohol.
 - A description of any drug or alcohol counseling, treatment or rehabilitation or re-entry programs that are available to employees or students.
 - A clear statement that the institution will impose disciplinary sanctions on students and employees (consistent with State and Federal law), and a description of those sanctions, up to and including expulsion or termination of employment and referral for prosecution, for violations of the standards of conduct. A disciplinary sanction may include the completion of an appropriate rehabilitation program.
- 2. A biennial review by the institution of its alcohol and other drug prevention comprehensive program to:
 - Determine its effectiveness and implement changes to its comprehensive alcohol and other drug prevention program and policies, if they are needed.
 - Ensure that its disciplinary sanctions are consistently enforced.

Palmetto College and the Palmetto College campuses provide annual notification to all students, faculty, and staff of their alcohol and other substance policy through email messaging two times per year (October 1 and February 1, see samples on next page). The messages are distributed through Human Resources and Student Affairs. This notification includes direct links to the following university policies:

The notification also includes information about and links to applicable state and federal law and explicit mention of the risks associated with the misuse of alcohol, illegal drugs, prescription medications, and other substances. Within the notification are direct links to resources for both students and employees who wish to voluntarily obtain assistance for substance dependency or misuse while also making note of the sanctions and consequences for students and employees who are not in compliance with university policy.

Beyond email message notifications, the PC campuses will also use various venues and settings to share messaging to educate about and prevent abuse of alcohol and other drugs. These venues may include the following: new student orientations, UNIV 101 course sections, TRiO—Opportunity Scholars Programs and Activities, and other ad hoc special activities and events related to AOD safety and security.

Biennial Reviews

Sub-committees on each Palmetto College campus serve as a biennial review work group. Committee members generally include those serving in these respective positions or designee:

- Associate Dean for Academic and Student Affairs
- Human Resources Director
- Director of Law Enforcement and Security

The committee meets as necessary with the following objectives:

1) to gather information and determine the effectiveness of AOD prevention/education efforts,

2) to review the previous biennial review and develop a list of any recommendations for the next biennium, with actionable objectives in each area to note and track improvements to the process.

Biennial Reviews are submitted every two years by October 1 and are archived on the Campus Security Statistics Reports webpages of the Palmetto College campuses.

 - 4. State of South Carolina sanctions include:
 - 5. It's a misdemeanor to possess lysergic acid diethylamide (LSD) or a Schedule I or II narcotic controlled substance category in SC. Penalties differ depending on the number of offenses. If this is your first offense, a fine of up to \$5,000 or two years in jail or both is the penalty. Marijuana is a Schedule I drug.
 - 6. A second offense is a felony. The fine is as much as \$5,000 or up to five years in prison or both.
 - 7. Each successive offense raises the fine, though not the jail time. Three offenses or more is a fine of up to \$10,000, and up to five years in prison or both.

- 8. Other Schedule I, II, III, IV, or V controlled dangerous substance is a misdemeanor for possession, with the exception of cocaine. A first offense penalty is a fine of up to \$1,000 or up to six months in jail or both.
- 9. A second offense or more incurs fines of up to \$2,000 or up to one year in jail or both.
- 10. A first offense of cocaine possession is a misdemeanor. The fine is up to \$5,000 or up to three years in prison or both. As with the other narcotics, a second offense is a felony.
- 11. The penalty carries a fine of up to \$7,500, as much as three years in prison or both. A third offense or more of cocaine possession has a penalty of up to \$12,500 or up to 10 years in prison or both.
- 12. If you're caught in possession of more than one gram of cocaine, judges presume intent to sell. This carries harsher penalties.

Sanctions are determined by a preponderance of the evidence in the context of 3 criteria: the severity of the infraction, the case history of the student and the attitude of the student during the conduct process.

 Research Papers, Loss of campus privileges, Mandatory Drug Testing, Required
 Alcohol-Drug Counseling, Residence Hall relocation, Residence Hall suspension,

 - Penalties for Simple Possession
 - Possession of a Controlled Substance: Drug Possession Laws

State of South Carolina sanctions include:

- o It's a misdemeanor to possess lysergic acid diethylamide (LSD) or a Schedule I or II narcotic controlled substance category in SC. Penalties differ depending on the number of offenses. If this is your first offense, a fine of up to \$5,000 or two years in jail or both is the penalty. Marijuana is a Schedule I drug.
- A second offense is a felony. The fine is as much as \$5,000 or up to five years in prison or both.
- Each successive offense raises the fine, though not the jail time. Three offenses or more is a fine of up to \$10,000, and up to five years in prison or both.
